LEGISLATIVE UPDATE

The two major events of the first week of the new legislative session were the election of John Perez (D-Los Angeles) as the next Assembly Speaker, replacing Assembly Member Karen Bass, and the release of the governor’s 2010-11 budget proposal. In the term limits era, a new speaker has pretty much become a tradition at the beginning of an election year, the theory being that it allows for a smooth transition to new leadership before the current leaders are termed out. Thursday’s election was a formality, as Assembly Member Perez had publicly gathered the votes over the fall to prevail over the other leading Speaker candidate, Kevin De Leon (D-Los Angeles). He is expected to officially take over the Speaker’s gavel sometime in February.

As expected, there wasn’t much good news in the governor’s 2010-11 budget proposal, although given the magnitude of the cutbacks of last year, there wasn’t much more that could be done to reduce funding for dental services. The governor’s budget would maintain the elimination of funding for non-emergency adult dental services, reduce eligibility for the Healthy Families program from 250 percent to 200 percent of the federal poverty level (and eliminate it entirely if federal funds are not forthcoming), and divert roughly half of the funds available through the First Five early childhood development program (some of which now goes to county-level dental services) to other social and developmental services programs. It also generally calls for overall Medi-Cal cost reductions through increased patient cost sharing, anti-fraud efforts, etc., the details of which remain to be seen. As he did last year, the governor is again declaring a fiscal emergency and asking the legislature to enact some of his proposals in the current fiscal year, in order to accelerate the projected savings. The legislature thus can be expected to at least hold hearings and take some action over the next month or so. We will again be looking for available opportunities to promote renewed funding of basic restorative services for adults.

CDA RECEIVES ADA STATE PUBLIC AFFAIRS PROGRAM GRANTS

We are pleased to report that the ADA’s State Public Affairs Program has granted a total of \$300,000 to assist CDA in its public policy work in 2010.

Specifically, ADA granted CDA \$200,000 to assist in our effort to prevent the placement of “fluoride and its salts” on the List of Chemicals Known to the State to Cause Cancer or Reproductive Toxicity that is produced by the State of California, Environmental Protection Agency, Office of Environmental Health Hazard Assessment (OEHHA). The Safe Drinking Water and Toxic Enforcement Act of 1986 (Proposition 65) requires the governor to publish this list of toxic chemicals each year. OEHHA is currently considering fluoride and its salts for inclusion in the Proposition 65 listing. A determination is expected within the next 13 months.

The ADA also granted \$100,000 to CDA to support our public affairs activities related to supporting children’s oral health programs. This is a continuation of an effort partially funded by the ADA Public Affairs Program last year.

COMPONENT ROYALTY PROGRAM
